Attendance sheets not submitted by MIDNIGHT on the due date will be paid the next payment date on the schedule. You can email your attendance sheets to subsidybills@chemchildcare.com or drop off attendance sheets in our drop box at the Child Care Council they will be date stamped the day they are received.

Payment will depend on CCTA (bill submission), attendance sheet submission to the Child Care Council and verification by the Child Care Council.
